Date: January 7, 2019

1. Per Regional Memorandum No. 714 s. 2018 paragraph 5, each division is enjoined to conduct a division initiated writeshop/cliniquing for the 2019 NSPC qualifiers prior to the conduct of the regional writeshop.

 6. This is a live - in activity. No registration fee to be collected. The first meal shall be breakfast of day 1 and last meal shall be dinner of day 2.
 7. Meals, snacks and lodging expenses shall be charged to Division Journalism Funds while travelling and other incidental experiences to school MOOE/local funds/SEF subject to the usual accounting and auditing rules and regulations.
