The **Dep-Ed, Division of Surigao del Sur**, now invites suppliers/manufacturers /distributors to apply for eligibility and to bid of the above stated project.

Delivery of the Goods is required within thirty (30) *Calendar Days*. Prospective bidders must have completed a similar contract within the last ten (10) years from the date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bid Documents in CD Form will be available only to prospective bidders starting November 30, 2020 – December 21, 2020 during office hours, upon payment of a nonrefundable fee for the Bidding Documents in the amount of Php 500.00 per item.

The **Dep-Ed, Division of Surigao del Sur** will hold a **Pre-Bid Conference on December 9, 2020 @ 10:00 AM** at 3<sup>rd</sup> Floor Division Office Conference Hall or via [meet.google.com/tth-fjme-icg](https://meet.google.com/tth-fjme-icg) which shall be open only to all interested parties who wish to join the Bidding.

Bid opening shall be on **10:00 AM of December 21, 2020** at **Third Floor Division Office Conference Hall** and through [meet.google.com/ino-wnnw-xep](https://meet.google.com/ino-wnnw-xep). Bids will be opened in the presence of the Bidders’ representatives who choose to attend. Late bids shall not be accepted.
