**WHEREAS**, there is an approved Purchase Request (PR) No. 22-11-257 for the provision of learning resources for the implementation of BE-LCP (Android Tablet) with an Approved Budget for the Contract of Five Million Two Hundred Thirty-Three Thousand Three Hundred Forty Pesos Only (Php 5,233,340.00);

**WHEREAS**, said procurement was included in the Supplemental Annual Procurement Plan / Project Procurement Management Plan of the Division Office for 2022;

**WHEREAS**, DepEd Surigao del Sur held a bidding conference on Procurement of Learning Resources for the implementation of Basic Education Learning Continuity Plan (BE-LCP) CY 2022 dated May 4, 2022 wherein Lot A (Android Tablet) was awarded to Machine and Computer World, Inc. being the winning bidder;

**WHEREAS**, the end-user made another Purchase Request dated 22 November 2022 for the provision of 406 units of android tablets having the same specifications with the original contract;

**WHEREAS**, the Bids and Awards Committee resort to Repeat Order as the mode of procurement subject to the conditions stipulated in Section 51 of RA 9184, to wit: within 6 months from the date of Notice to Proceed and did not exceed twenty-five percent (25%) of the quantity in the original contract;

- a. To award to **MACHINE AND COMPUTER WORLD, INC.** for **item no. 1** for the provision of learning resources for the implementation of BE-LCP (Android Tablet);
- b. To recommend to the Schools Division Superintendent for approval of the award of the above stated contract to **MACHINE AND COMPUTER WORLD, INC.** with the total amount of Five Million Two Hundred Thirty-Three Thousand Three Hundred Forty Pesos Only (Php 5,233,340.00).
