

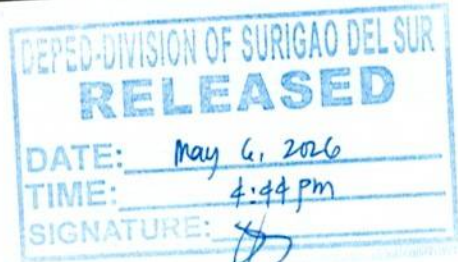

COMPETENCY ENHANCEMENT TRAINING OF SCHOOL LEADERS

1. Greater autonomy for school leaders is associated with better student performance. However, autonomy alone does not guarantee improved school leadership. School leaders also need an explicit mandate as well as the capacity, motivation, and support to use their autonomy to focus on the responsibilities most conducive to improving school and student outcomes.
2. In view of the foregoing, the Human Resource Development Section, together with the select Learning Facilitators, shall conduct a Competency Enhancement Training of School Leaders, anchored on the Philippine Professional Standards for School Heads (PPSSH), on **May 6-8, 2026**. The venue will be at **VFS Agri-Tourism and Adventure Park, Tago, Surigao del Sur**.
3. This activity aims to
 - *Demonstrate understanding of the DepEd vision, mission, and core values to foster shared understanding and alignment of school policies, programs, projects, and activities.*
 - *Demonstrate understanding of policies, guidelines, and issuances in managing finances such as allocation, procurement, disbursement, and liquidation aligned to the school plan.*
 - *Demonstrate knowledge and understanding of school-based review, contextualization, and implementation of learning standards.*
 - *Demonstrate knowledge and understanding of the implementation of the performance management system in improving school personnel and office performance.*
 - *Demonstrate knowledge and understanding of involving the community, such as parents, alumni, authorities, industries, and other stakeholders; and*
 - *Increase knowledge on how to prepare oneself for the examination and gain examination tips from experienced takers.*
