NATIONAL WOMEN'S MONTH CELEBRATION (NWMC) 2022**

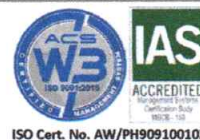
1. As part of this division's thrust towards gender mainstreaming, all women and men division personnel, including everyone in the field, are hereby enjoined to participate in the virtual launching which will be held on **March 01, 2022 (Tuesday)** at the **Schools Division Office, Balilahan, Mabua, Tandag City** and will be broadcasted live via **DepEd Tayo - Surigao del Sur** and **Ala-GAD ng DepEd-SurSur** Official Facebook Pages.
2. The 2022 NWMC endeavors to highlight the gains achieved for women and girls, assess actions towards gender equality, and look forward to steps that must be taken to ensure progress in empowering women. With the country still reeling from the COVID-19 pandemic, studies and data show that the health crisis stalled movements towards gender equality, worsening inequalities, further exposing gender gaps, and exacerbating vulnerabilities in social and political, and economic aspects.
3. To cap the six-year recurring theme, the 2022 NWMC shall focus on the sub-theme: **Agenda ang Kababaihan, Tungo sa Kaunlaran.**
4. All participants are required to wear their **best Purple Attire** during the launching day and all Tuesdays of March to signify support for women's empowerment and equality.
5. To spread the advocacy online, the hashtags **#WomenMakeChange** and **#alaGADngSurSur** shall be used in all posts related to the celebration. This division is also encouraged to post on or tag the official Facebook Page, **Ala-GAD ng DepEd-SurSur**, which can be accessed through **<https://www.facebook.com/alaGADngSUR>**.
6. In consonance with the PCW Memorandum Circular No. 2022-01 dated February 11, 2022, all districts are encouraged to conceptualize their own activities thereby helping the campaign more visible in their respective areas of responsibility.

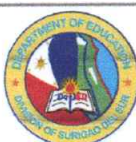
