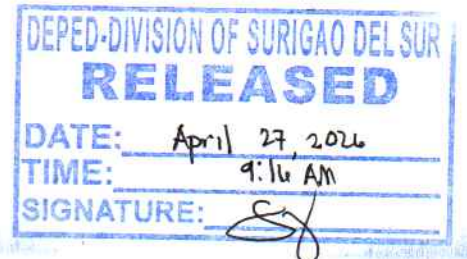

STRENGTHENING SCHOOL READINESS: CAPACITY BUILDING FOR TEACHER-ADVISERS ON BERT FACILITATION

1. Batang Empowered and Resilient Team (BERT) is program introduced by Save the Children Philippines (SCP) that educates young learners on identifying potential risks and hazards, both at home and in school, while teaching them appropriate actions to take before, during, and after disaster or emergency.
2. BERT trains children to become facilitators to help teach other children about risk reduction and resiliency. The program supports DepEd Order No. 23, s. 2015 entitled "Student-Led School Watching and Hazard Mapping".
3. Teacher-Advisers are essential in the implementation of the Batang Empowered and Resilient Team (BERT) as they serve as primary mentors who guide and monitor learners' overall well-being. They help identify learners needing support and ensure timely, appropriate interventions through coordination with school personnel and parents. Their active involvement strengthens learner resilience, promotes a supportive school environment, and ensures the effective delivery of BERT initiatives.
4. In line with this, this Division shall conduct a capacity building entitled, **Strengthening School Readiness: Capacity Building for Teacher-Advisers On BERT Facilitation**, at Ocean Point Beach Resort, Lianga, Surigao del Sur on May 12-14, 2026.
5. The participants in this activity are the School DRRM Teachers- Adviser. Enclosed herewith are the list of participants.
6. Meals, snacks, and accommodation expenses will be charged to the 2026 HRD Funds.
7. Travel expenses, per diem, and other incidental expenses of the participants shall be charged to the Local Funds, School MOOE, Program Support Fund (PSF), Local School Board- Special Education Fund (LSB-SEF), and other funding sources, in compliance with the existing accounting and auditing rules and regulations.
