RECONSTITUTION OF THE DIVISION BIDS AND AWARDS COMMITTEE (BAC) IN VIEW OF THE TRANSITION FROM R.A. 9184 TO R.A. 12009

To: Assistant Schools Division Superintendent

1. In light of the transition from Republic Act No. 9184 (Government Procurement Reform Act of 2003) to Republic Act No. 12009 (Philippine Procurement Modernization Act of 2024) and in accordance with its Implementing Rules and Regulations (IRR) and other related issuances, there is a need to reconstitute the Division Bids and Awards Committee (BAC) of the Schools Division of Surigao del Sur to align with the new provisions of the law.
2. This reconstitution aims to strengthen transparency, accountability, and efficiency in procurement processes, and to ensure readiness in implementing reforms introduced under RA 12009.
