ANALYSIS OF RAPID MATHEMATICS ASSESSMENT (RMA) RESULTS AND PREPARATION OF INTERVENTION PLAN

Public Schools District Supervisors/ District In-charge To: Heads, Public Elementary & Integrated Schools All Others Concerned This Division

- 1. In line with the National Mathematics Program, as per DepEd Order No. 16, s. 2023, aimed at improving students' numeracy and mathematical skills, all Grades 1-3 teachers handling Mathematics are required to analyze the Rapid Mathematics Assessment (RMA) results. This analysis is crucial in identifying learning gaps and areas for targeted intervention.
- 2. Grades 1-3 Mathematics teachers must submit a detailed analysis of the RMA results to the School Head on or before September 30, 2024. The analysis should highlight key learning gaps and areas where learners need additional support.
- 3. Based on the submitted analysis, the School Head, together with the concerned teachers, must prepare a realistic and comprehensive intervention plan to address the identified learning gaps.
- 4. The School Head shall submit the finalized intervention plan for review and approval by their Public Schools District Supervisor or District In-Charge on or before October 4, 2024.
- 5. All concerned personnel are expected to collaborate actively in this process to ensure timely and effective interventions that will enhance learners' mathematical proficiency.
- 6. Attached is a suggested template for the Intervention Plan and the Monitoring Tool for proper guidance.
- 7. Immediate and wide dissemination of this memorandum is desired.
