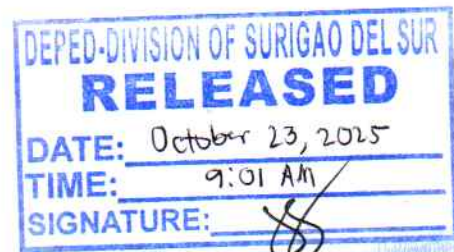

ONLINE ORIENTATION ON DO NO. 40, S. 2012 "DEPED CHILD PROTECTION POLICY" AND DO NO. 90, S. 2025 "REVISED IRR OF RA NO. 10627"

1. The Learner Rights and Protection Office is dedicated to upholding the safety, dignity, and well-being of every learner within the educational system. Its primary goal is to ensure that all students are protected from any form of violence, exploitation, discrimination, bullying, neglect, and other forms of abuse—whether physical, emotional, verbal, or digital—within school environments. LRPO works proactively to create safe, inclusive, and supportive learning spaces by implementing child protection policies, conducting awareness campaigns, facilitating reporting mechanisms, and coordinating with relevant agencies to respond to incidents swiftly and effectively. Through its advocacy and intervention efforts, LRPO empowers learners to thrive academically and socially in a climate of respect and security.

In line with this, an Online Orientation on the Learner Rights and Protection Policy is scheduled for **October 27, 2025 (Monday), from 2:00 PM to 4:00 PM**, and will be conducted virtually via <https://tinyurl.com/OnlineCPC>. This session aims to promote awareness and understanding of the policies designed to safeguard learners from all forms of abuse, discrimination, and violence in schools, and to strengthen the collective commitment to creating safe and inclusive learning environments.

In addition, attendance to the said online orientation is mandatory for all Child Protection Committee (CPC) members from both public and private schools across Surigao del Sur, as part of their responsibility to uphold and implement learner protection policies within their respective institutions.
