**ESTABLISHMENT OF THE LEARNER RIGHTS AND PROTECTION DESK  
DURING THE CONDUCT OF DASD 2025**

To: All Public Schools District Supervisors/ District In-charge  
All Project Development Officers I  
All Other Concerned

- To uphold the principles of inclusive, safe, and rights-based education, the *Learner Rights and Protection Desk* will be formally established during DASD 2025. This initiative aims to institutionalize mechanisms that safeguard the welfare of all learners, ensuring their voices are heard and their rights are respected across all educational settings.
- In line with this, the Youth Formation Section of the Schools Governance and Operations Division has mandated all *Project Development Officers I (PDO I)* in Surigao del Sur to establish a Learner Rights and Protection (LRP) Desk in their respective billeting quarters per municipality during the conduct of DASD 2025, scheduled from November 10-12, 2025.
