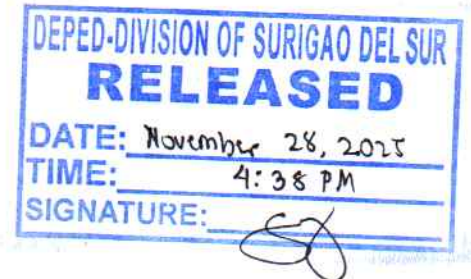

DIGITIZATION AND QUALITY ASSURANCE OF SUPPLEMENTARY LEARNING RESOURCE FOR SPECIAL PROGRAM (ALTERNATIVE LEARNING SYSTEM))


1.
