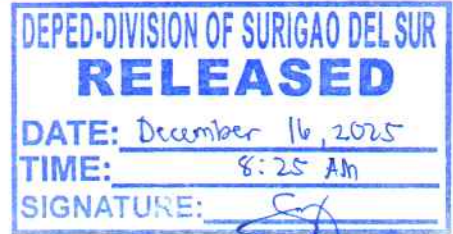

3. The following NASH takers identified in Item 6 of DM 69, s. 2025 may participate regardless of whether they meet the Qualification Standards (QS) for the School Principal I:

- a. Head Teachers;
- b. Assistant School Principals;
- c. FY 2021 NQESH takers under category C;
- d. FY 2023 NQESH takers under category B; and
- e. FY 2023 NQESH takers under category C.

4. As stipulated in Item 6 of DM 97, s. 2025, Head Teachers and Assistant School Principals whose competency level is classified as “With Developmental Areas” may also opt to take the FY 2025 NASH – Batch 2.

19	Master's Degree in Education, or Educational Management or Educational Leadership; or Master's degree in relevant learning area with at least 9 units in Management	32 hours of training in any of or a cumulative of the following: Curriculum Pedagogy, School Management and Operations, Instructional Leadership acquired within the last 5 years	5 years teaching experience and 1 year relevant experience in any of the following: learning area coordination, subject area supervision, school management and operations, instructional supervision	RA 1080, as amended (Teacher)

6. The assessment fee of Php 720.00 shall be collected to cover expenses related to operations, logistics, administrative arrangements, orientations/capacity-building activities, and other requirements for the administration of FY 2025 NASH Batch 2.
