LEARNER RIGHTS AND PROTECTION ON WHEELS

1. The goal of the Learner Rights and Protection Office (LRPO) is to ensure that all learners are safeguarded against all forms of violence, exploitation, discrimination, bullying, and other types of abuse in schools.
2. The Division Office of Surigao del Sur is responsible for organizing and conducting capacity-building activities for members of the Child Protection Committee and Guidance Counselors/Teachers. These activities will focus on identifying students who may be experiencing significant harm, based on physical, emotional, or behavioral signs.
3. In line with this initiative, the Youth Formation Section of the Schools Governance and Operations Division will conduct the **“Learner Rights and Protection on Wheels”** at Bitaugan Elementary School, San Miguel, Surigao del Sur—one of the last mile schools in the municipality—on Monday, July 14, 2025.
