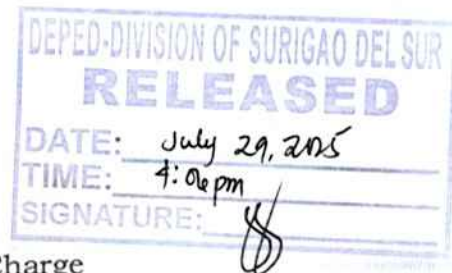

ADOPTION OF THE GUIDELINES ON THE SUPERVISION AND IMPLEMENTATION OF THE DEPED CAREER GUIDANCE PROGRAM FOR SCHOOL YEAR 2024-2025 AS THE GOVERNING FRAMEWORK FOR SCHOOL YEAR 2025-2026

1. In reference to Joint Memorandum OUOPS No. 2023-0-8149, titled "*Guidelines on the Supervision and Implementation of the DepEd Career Guidance Program for School Year 2024-2025*," and DM-OUOPS-2024-11, "*Reiteration of the Guidelines on the Supervision and Implementation of the DepEd Career Guidance Program for School Year 2024-2025*," the Department of Education (DepEd), through the Office of the Undersecretary for Operations (OUOPS) and the Office of Curriculum and Teaching (OUCT), hereby reaffirms the continued effectivity of the said guidelines. This reiteration establishes the referenced order as the standing policy for the Career Guidance Program (CGP) until a new DepEd Order is formally issued.
2. The Department of Education – Surigao del Sur Division, through the **Youth Formation Division**, shall adopt the "*Guidelines on the Supervision and Implementation of the DepEd Career Guidance Program for School Year 2024-2025*" as the governing framework for **School Year 2025-2026**. It shall continue to implement its provisions until a new DepEd Order is issued.
