
### PARTICIPATION TO THE REGIONAL ALS AND SHS-TVL SUMMIT CUM SYNCHRONIZED NATIONAL CERTIFICATION ASSESSMENT

To: Public Schools District Supervisors / District-in-Charge Concerned School Head TVL Teachers This Division

- 1. In alignment with the objective of providing quality, relevant, inclusive, and responsive education, DepED-Caraga Region is set to initiate a Regio the Alternative Learning System (ALS) and the Senior High School Technical Vocational Education (SHS-TVL) Summit Cum National Certification Assessment on December 17 to 19, 2024, at the Nasipit National Vocational School and the Amontay Beach Resort and Convention Center in Nasipit, Agusan del Norte.
- 2. The primary objectives of this convergence are as follows:
  - Review and update the skills of ALS and SHS-TVL learners.
  - 2. Foster stronger collaboration among stakeholders.
  - 3. Increase the likelihood of learners passing the assessment.
- 3. There are 300 learners from select schools of the Division who had been a graduate during the school years 2021-2022, 2022-2023, and 2023-2024. These graduates have been given the opportunity to participate in this assessment process.
- 4. Each participant will incur no costs for meals, snacks, and travel expenses, which will be covered by the GAS-OSEC 13-24-6640/Sub-ARO RO-13-24-1302. Their accommodation will be provided at NNVS. Additionally, teachers accompanying the learners will charge their meals, snacks, travel expenses, and per diems to their respective School MOOE and other local funds.
- 5. The processing of meals and snacks will be facilitated by the designated Division focal person. For travel expenses, learners from the Implementing Units (IUs) will have their costs facilitated by their schools through the downloaded funds. Similarly, for non-IUs, the TVL teachers who accompany the learners are responsible to process the travelling expenses through a cash advance using the prescribed the documentary requirements which can be referred to the accounting unit.
