REITERATION ON THE OBSERVANCE OF MINIMUM PUBLIC HEALTH STANDARDS IN LIGHT OF THE POSSIBLE RESURGENCE OF COVID-19 CASES AFTER HOLY WEEK HOLIDAYS

1. Considering the current increasing trend of COVID-19 cases in our country and concerns on SARS COV-2 variants, all T&NT personnel are reminded to observe the minimum public health standards being implemented especially during the upcoming Holy Week Holidays. Resurging of cases were observed after long holidays last December 2020, hence it is prudent to say that there are high chances that the same will happen this time if we will loosen our preventive measures.
 2. In this regard, all personnel are encouraged to:
 - a. Stay at home during holidays.
 - b. Avoid enclosed and crowded areas.
 - c. Observe proper hand hygiene through washing their hands with soap and water or use alcohol-based hand sanitizer.
 - d. Wear face mask covering both mouth and nose.
 - e. Practice proper respiratory etiquette.
 - f. Observe physical distancing at least 1 meter apart.
 3. Personnel who will experience any symptoms of COVID-19 upon resumption to work after holidays are required to inform their immediate supervisor to arrange for an alternative work arrangement, if not possible they should file sick leave. The said personnel should also seek medical consult.
