Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

3. Interested bidders may obtain further information from the DepEd Schools Division Office Surigao del Sur at Telephone No. (086)- 211-3560 and inspect the Bidding Documents at the address indicated herein for Issuance of Bidding Documents during office hours.
4. A complete set of Bidding Documents may be acquired by interested Bidders from the Bids and Awards Committee Secretariat **DepEd SDO –Surigao del Sur** and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00) per Cluster.
5. Considering the current situation due to the pandemic (COVID-19) and the mandate to observe social distancing, **DepEd SDO** will hold a pre-bid conference for this Project on **July 21, 2021 through videoconferencing, at meet.google.com/ycc-croy-fbe** which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat on or before **August 4, 2021; 10:00AM** at **BAC Office - DepEd SDO of Surigao del Sur- Balilahan, Mabua, Tandag City. Late bids shall not be accepted.**
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on **August 4, 2021; 10:10** at **3rd Floor DepEd Conference Hall, DepEd SDO - Balilahan, Mabua Tandag City** and through **videoconferencing at meet.google.com/tcu-ycoa-wfo**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. **For the purpose of constituting a quorum**, both the physical and virtual presence of the BAC and TWG members shall be considered pursuant to GPPB Resolution No. 09-2020.

The **DepEd** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
