Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bid Documents in CD Form will be available only to prospective bidders starting **March 11, 2021 to March 31, 2021** during office hours, upon payment of a nonrefundable fee for the Bidding Documents in the amount as stated above.

The **Dep-Ed, Division of Surigao del Sur** will hold a **Pre-Bid Conference** on **March 19, 2021 @ 10:00 AM** at *3<sup>rd</sup> Floor Division Office Conference Hall* which shall be open only to all interested parties who wish to join the Bidding.
