Delivery of the Goods is required within thirty (30) Calendar Days. Prospective bidders must have completed a similar contract within the last ten (10) years from the date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bid Documents will be available only to prospective bidders starting **July 19, 2021 to August 11, 2021** during office hours, upon payment of a nonrefundable fee for the Bidding Documents in the amount as stated above.

The **Dep-Ed, Division of Surigao del Sur** will hold a **Pre-Bid Conference** on **July 27, 2021 @ 3:00 PM** through video conferencing at meet.google.com/wkg-kxpp-ybj which shall be open only to all interested parties who wish to join the Bidding.

Bid opening shall be on **10:00 AM of August 11, 2021 at Third Floor Division Office Conference Hall** and via meet.google.com/czb-fwaw-nkf which will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
