Delivery of the Goods is required within thirty (30) *Calendar Days*. Prospective bidders must have completed a similar contract within the last five (5) years from the date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bid Documents will be available only to prospective bidders starting **September 16, 2021 to October 7, 2021** during office hours, upon payment of a nonrefundable fee for the Bidding Documents in the amount as stated above.

The **Dep-Ed, Division of Surigao del Sur** will hold a **Pre-Bid Conference** on **September 24, 2021 @ 1:00 PM** through video conferencing at [meet.google.com/sok-moyg-sma](https://meet.google.com/sok-moyg-sma) which shall be open only to all interested parties who wish to join the Bidding.

Bid opening shall be on **3:00 PM of October 7, 2021** at **Third Floor Division Office Conference Hall** and via [meet.google.com/gqv-jnep-qms](https://meet.google.com/gqv-jnep-qms) which will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
